### DELAWARE

# **Downtown Development District Grants**

- Up to 20% rebate for qualifying construction projects
- Administered by Delaware State Housing Authority
- Capped at \$1M per property

## **State Historic Preservation Tax Credits**

- Assistance with the preservation and rehabilitation of Historic Buildings
- Administered by the Division of Historical & Cultural Affairs

#### KENT COUNTY

# **DDD Matching Grant**

- Up to \$10,000 matching grant for any qualified DDD project in Kent
- Administered by Kent County Levy Court

#### TOWN OF SMYRNA

## **Electric Utility Discount**

- 50% discount on monthly metered electric utility for 6 months
- Chapter 70, Article IV, Section 70-190

## **Waived Impact Fees**

- Impact fees shall be *fully waived*, provided the the building updates are similar in kind and do not cause a significant increase in public services.
- Chapter 32, Section 32-2

# **Building Permit Fees Cap**

- Qualifying projects in commercially-zoned or historic areas shall have a cap of \$1,000 on all building permits.
- Chapter 18, Article 1, Section 18-29

# Waiver of Taxes, Charges & Fees

- Town Council may waive, in whole or part, any tax, charge, fee, or obligation to the town. This may cover property taxes, impact fees, building permits, and/or electric utility charges.
- Chapter 18, Article XII, Section 18-801

#### TOWN COMMITTEES

# **Revolving Loan Fund**

- Access to capital through a revolving loan fund, funded by the USDA RD-LEG program, to assist commercial and residential development, renewal, improvement of businesses and creation of jobs.
- Administered by the Smyrna Redevelopment Authority (RDA)

# **Facade Improvement Grants**

- Up to \$1,000 grant for business/property owners who address storefront conditions.
- Administered by the Smyrna Redevelopment Authority (RDA)

# **Vacancy Incentive**

- A financial incentive for property and business owners to mitigate the negative impact of vacancy.
- Administered by the Smyrna Redevelopment Authority (RDA)
